MINUTES October 9, 2018 Hispanic Unity of Florida Board of Directors Meeting

Call to Order

4:00pm officially called to order by Charles (Chuck) Tatelbaum.

Presentations

Chuck welcomed George Mihaiu to the HUF board, he received the HUF pin and photos were taken. George shared his background. He's a publisher of local magazines. He feels honored and proud to be a part of the HUF board. The American dream for everyone which is why he has joined the board and hopes to help further the agency's Mission.

• Mission Moment: Program Visits.

-Steve Sampier: Very happy to see many members are able to report on their program immersion. He went to observe the CWF program.

-Willy Gomez: CWF it was engaging, helpful for interviewing, resumes and skills for company research. This program helps people to become independent by helping them secure a good job.

-Lucia Rodriguez: She shared her experience at the E-Summit from the Marketing perspective. (She also participated in a program tour.)

-Emma Pfister: Legal Immigration Clinic - she assisted with intakes. She listened to the stories and she saw the need of individuals from all walks of life. It was a very interesting experience.

-John Guerrero: Family Strengthen program. It was a support group that offers helpful resources. -Hector Lima: CWF program he was really impressed by the level of professionalism of the HUF staff. There were 12 female clients. Well ran and strong level of content was at the HUF level.

- Member to Member Meet-Up's: Carolina Cardozo met up with Angie Stone and they got to know one another better. John Guerrero and Chuck met up last Friday to talk about the future vision of HUF. Lucia Rodriguez and Willy Gomez recently had lunch to catch up.
- Circle of Friends Annual Reception---Invitations & Event, Josie Bacallao. The invitation was passed out and she shared this is the renewal time for those that attended last year. Folks invited last year will be automatically invited again. Please share the invitations with more friends. This year we have a match, \$25k which is being used out of The Jim Moran Foundation \$1 million gift. She shared we are behind in individual giving for the year and that this had been where the board wanted to focus and grow. Peace Love World, is working with us for t-shirt fundraising campaign which will help the Pathway to Citizenship program. Using hashtags, etc. Phase 1 is at the event Circle of Friends donors giving \$250 and up will receive a t-shirt. T-shirts are unisex but they do come in V and scoop styles. She shared a producer of Spanish digital media has offered to create a Spanish PSA for us and to take HUF on a media tour in 2019. We will be encouraging \$50 donations. A separate \$20K grant from NAC will allow us to pay for the PSA production costs and to purchase the t-shirts.

Josie shared that all current Circle of Friends members were invited to the event. She encouraged board members to invite any and all potential donors who may have an interest in HUF's mission. BBX has the ability to accommodate a large group (125-150 capacity). We would like Alan Levan to be there but there was a recent family tragedy. Chuck will ask him if he can speak at the event. Chocolate Hoffman's ice cream will be served.

Governance Chair, Steve Sampier

- 2019 Board Member Slate (Vote will be in November). Chuck Tatelbaum has indicated his willingness to serve a second year term as Chair of the Board. Lucia Rodriguez also indicated she too is willing to serve a second year as Chair-Elect. Willy Gomez will continue as Past Chair. Emma Pfister is willing to serve a second year as Treasurer position. John Guerrero is being recommended for Secretary. Steve Sampier thanked Christina Paradowski for her work in the past year as Secretary. Steve asked for an additional nominations from the floor. No additional recommendations were made. The Officer slate for 2019 was finalized and a vote will be taken at the November 13 board meeting.
- Board Recruitment. Steve asked if anyone had identified any potential candidates. Lucia shared she has a list she is working on. John plans to reach out to a friend he's working on, as well. Steve reminded the other chair committee's we still need recruits for committees not just board candidates.

Finance Committee Chair, Emma Pfister

• TJMF 100th Birthday Grant

Josie Bacallao walked the board through the steps that had been taken regarding the grant including how HUF plans to use the funds based on numerous discussions with TJMF representatives, the "Centurion" board committee and senior HUF staff. She also shared possible fundraising opportunities to utilize the funds as a match, announcing the gift and recognizing the foundation. The board discussed all these items. The board members agreed on the proposed utilization of the funds. They also agreed that at this time HUF would not make any public announcements of the gift. Josie shared she is working on a meeting with the Community Foundation to seek their advice on fundraising. (HUF already has a proposal from James Mueller.) Lastly, the HUF team will develop recognition ideas for the foundation and welcomed any ideas from the board.

Reserves Policy

Emma Pfister and Virginia Cielo reviewed the policy and a discussion ensued. Willy Gomez moved to accept the HUF Reserves Policy with one edit (changing second paragraph in the "Reserves" Fund to restricted from unrestricted). John Guerrero provided the second. The motion passed.

HUF Financial Institution Proposal Review & Recommendation

Emma Pfister and Virginia Cielo walked the board through the history of the project and the various options presented by three possible financial partners, including our current one. They then reviewed in detail the BB&T proposal, the line of credit and refinancing the mortgages. An extensive discussion and Q&A ensued. Then a discussion on the mortgage and the options. Dan Herz suggested that HUF request an additional \$100K with the LOC and to ask for a two-year line. Others agreed.

Willy Gomez moved to accept the BB&T proposal and John Guerrero provided the second. The motion passed unanimously.

Chuck Tatelbaum offered Tripp Scott's assistance to provide support to HUF with the closing.

Other

Board Members agreed to keep the December board meeting and have the holiday social immediately after. Each board member would bring in a dish (preferably homemade) to share with the board and staff.

HUF Program Task Force Minutes: October 10, 2018

Attendee's: Steve Sampier (Chair), John Guerrero, Carolina Cardozo, Dr. Rolando Garcia, Felipe Pinzon & Felina Rosales-Furer

Task Force Purpose: Provide guidance associated with the development and implementation of HUF's programmatic components of the strategic plan.

1. Program Committee Chair- Steve Sampier

a. 2016 Strategic Plan/Programs must be revised/updated. 2016 Strategic Plan/Programs to be revised. He shared the history of the creation of this task force and how HUF arrived at where we are now with all of the many programs. Collaboration with Broward Schools helped HUF to get to where we are now. We are looking toward the future and the potential growth into Palm Beach County. HUF's strategic plan is reviewed by the board every 3 years and from there HUF staff works on an operation list.

Felipe Pinzon reminded the committee that our goal as an agency is reflected in the mission statement. As well as, program decisions are in line with our funding opportunities. The Jim Moran gift has now given us opportunities for investment.

2. Update on strategic plan

a. Service Gaps. 2016 to now:

Education: Elementary school, postsecondary and employment pathways, fully integrated financial education in children and youth service. We have now incorporated by using a (2 generational approach) or what we are calling COMPASS.

Economic Development: Better jobs, asset building (vocational skills and home ownership). Large foundations are going back to workforce and career pathways.

Civic Engagement: Citizenship, advocacy, voter registration and leadership development. All three components are being integrated into our current programs. Rolando Garcia shared we need more leadership development, so people can be advocates interfacing with legislators. With the help of the Aspen Institute, we are piloting in Strahan High and Apollo middle school. Pathways to Progress Program: skills, income and assets. In collaboration with Memorial Hospital we have a medical assistance program where clients upon completion of the program will be placed into an employment position.

b. Funding. More money helps bring even more money. We need to scale COMPASS to six schools. The two generation approach is the model CSC and many foundations want to fund, due to its evidence based performance.

3. Geographic Expansion

- Miami sustainability plan. Pathways to Citizenship will be moving into the YWCA. Now starting pilot program at Miami Dade College to assist LPR's gain Citizenship on 2 campuses in 2019; naturalization form preparation assistance. This also helps us gain funders in Miami-Dade. Funded currently provided by Citi group, the Mayor's Office and client fees.
- Broward Central and North areas. There is a large group of working poor in Pompano Beach/Deerfield area who are underserved. Rolando shared he can help HUF get space at BCC in Deerfield. This underserved population has been identified by school based demographics. Pine Center BCC is another opportunity for Citizenship aid too.
- c. West Palm Beach Should we explore? In the near future Felipe and Magaly Alvarado are meeting with the Director of Public library system to discuss Citizenship expansion. Felipe also recently met with the El Sol organization in Jupiter for potential collaboration.
- 4. Community Needs (may change target population and service delivery model)
 - a. Public Charge. You would have to have money and healthy in order to become a Citizen if this policy passes. HUF needs to prep to address changes this policy would bring.
 - b. TPS. Haitian's in Dade & Broward face uncertainty. We have to come up with a potential plan if this becomes the reality.

5. Next Steps

- In the future there may be the potential need to help undocumented immigrants.
- Leverage the assets we have currently. Perhaps we just stay where we are and then penetrate further in our area. Focus on closer to home and our existing partnerships. Focus on making Miami-Dade more sustainable before we expand in Palm Beach County.
- Our investment with advocacy would be to partner with those organizations already registering people to vote.
- Could we become the expert and consult for implementation of program models?
- Let's do better before expanding.
- Citizenship Miami, Workforce and 2-generation approach (COMPASS) are the 3 program priorities.
- Need to look at affordable housing needs and improvement. Need to understand the client barriers our staff is encountering with our clients.
- The committee would like the data and a review of the COMPASS program at the next meeting.

Someone asked about HUF's connections to Baptist Health leadership. Committee members might explore who might be a good recruit – perhaps in Q1/2019. Baptist now have offices in Boca Raton.

3. By Laws. Are there any policy issues to correct or clarify from edits sent by Steve this week? Important not to restrict terms to one year especially if someone willing to serve longer. Discussed having board members coming in at any time throughout the year. Barbara Grevior would like to see a more organized schedule for processing recruits. Need to share tracking more openly when people rolling off with board so recruitment stays fresh in mind. Vacancy, suspension, extension and term off were also discussed. When does clock start over or continue regarding completion of term? Exceptions should be addressed as they arise. If gone for less than a year then you continue original term if you're gone more than a year then a six year term starts again.
