CHRIS L. SMITH

GOVERNMENTAL AFFAIRS

Tripp Scott (TSE) CONSULTING

Sen. Chris Smith began his public service as a youth. He continued this service after college by serving on local boards with the City of Fort Lauderdale. In 1995 he was appointed to the City's Planning and Zoning Board. At a time of tremendous development within the City of Fort Lauderdale, Sen. Smith fought to seek a balance between the need for economic development and the rights of existing property or homeowners.

In 1998 Sen. Smith was elected to the Florida House of Representative serving the City of Fort Lauderdale and six surrounding municipalities. In his third term he was elected Democratic Leader of the Florida House of Representatives. After being term limited out of the House of Representatives, Sen. Smith was elected to the Florida Senate in 2008 representing Broward and Palm Beach County. After redistricting, Sen. Smith represented 14 municipalities in Central Broward County. In only the third year of his first term he was once again elected Democratic Leader of his chamber. This accomplishment of serving as Democratic Leader of the House and Senate has only been done by a few members of these August bodies. As Democratic Leaders, Sen. Smith once again set Democratic policy on local and statewide issues.

Sen. Smith has discussed Florida law and politics on many national and local programs such as CNN, MSNBC, Fox News Channel, NPR, Jim Defede Show, Michael Putney Show and numerous other media outlets. Senator Smith has received many awards including, the Florida Association of Criminal Defense Lawyers (FACDL) Legislative Champion of Justice, Legislator of the Year from the American Jewish Congress, Humanitarian Award from the Young Democrats and many more.

He was consistently rated by the *Miami Herald* and the *South Florida Sun Sentinel* as a top legislative leader. Sen. Smith's commitment to the community includes serving on the Board of Directors for Mount Bethal Community Development Corporation, Inc., Youth Advisor for the NAACP, Vice President for The Gold Coast Alumni Chapter of Johnson C. Smith University and Alpha Phi Alpha Fraternity, Inc.

Senator Smith is a graduate of Johnson C Smith University, in Charlotte North Carolina and a graduate of the Florida State University College of Law. He is a partner with the Tripp Scott Law Firm. He is married to Desorae Giles-Smith and the proud father of two, Christopher and Christian.

- Worked most recently with Steve Sampier on recruitment strategy and procedure
- Offered his home (in Miami) for HUF event

Hispanic Unity of Florida Board of Directors Meeting Minutes Tuesday, December 3, 2019

Call to Order/ Roll Call

At 4:00pm.

Chuck Tatelbaum reminded everyone that a portion of the book proceeds from Susie Levan book go to Hispanic Unity.

Governance: 2020 Board Officer Slate

Steve Sampier reviewed the proposed 2020 HUF Officer's slate. The governance committee recommends the following individuals: Lucia Rodriguez, Chair; John Guerrero, Chair-Elect; Emma Pfister, Treasurer; Christina Paradowski, Secretary; Chuck Tatelbaum, Past-Chair.

Motion: Steve moved to accept the 2020 Board Officer Slate and Willy Gomez provided the second. The motion passed unanimously.

2020 Board Meeting Calendar

The proposed 2020 Board Meeting calendar was distributed.

Motion: Steve Sampier moved to accept the 2020 meeting dates and Rolando Garcia provided the second. The motion passed.

Giselle Cushing shared her program immersion experience. She attended the Unity4Kids Halloween party (of course, she was in full Halloween regalia which the kids loved). Giselle really loves children and she shared how important it is for board members to participate in program events and mmersion opportunities as a way to connect with HUF's mission.

Programs

Steve Sampier and Felipe Pinzon shared an update on the Children's Service Council RFP submission. CSC is a very strong partner and a major funder with \$100M in program funding distributed annually. Unity4Teens was created by HUF nearly 20 years ago. We are serving six schools with a \$1.6 million dollars budgeted from CSC. Last week, HUF submitted two proposals for a total of \$3.5 million. HUF would like to serve middle schools and the high schools where these youth will later transfer to. Felipe personally met with every Principal of the schools HUF proposes to serve starting in the fall of 2020. Felipe shared HUF is expanding its career and college readiness program with employability and soft skills as part of our 2Gen implementation.

Development Presented by Shani Wilson.

Shani shared the results of the September 20, 2019 Entrepreneur Summit at NSU. HUF held six workshops and had 25+ exhibitors in addition to our five American Dreamers and a extremely well-received Networking Plenary followed by a networking session. Shani reviewed the marketing and public relations activities and results including in kind support. This event is mission-focused: assisting immigrant entrepreneurs.

HUF had a return of investment of 65% from a *fully-loaded* P&L (we added direct expenses as well as staff time). This is the highest ROI for this event for HUF. (The standard is 50% ROI for events.)

In 2019 the summit was wholly designed, sold and executed by Shani Wilson with little involvement by Josie Bacallao. The latter is a significant milestone for the organization as it develops the next generation of development leadership and builds organizational depth. Not having the CEO involved also was a positive to the bottom line of the event.

Shani's recommendation is to continue the Summit in 2020 in its more stream-lined format. The board members agreed.

End of the Year Campaign and \$10k Challenge Gift Updates

Shani shared the changes to HUF's main donation page and our tie into the national Giving Tuesday on December 3, 2019. HUF will promote the end of year campaign and Giving Tuesday on social media where Facebook will double any donations received on that day. She shared the updated board member individual giving pages which also include the end of year messaging. She shared an update on the end of year campaign which included a \$10,000 challenge grant by the Miniachi's and the match by the Ansin Foundation. The next goal is to raise \$20k by the end of the year.

HUF 2020 Public Policy Platform

Rolando Garcia shared HUF legislative platform and priorities approved by the Public Policy & Advocacy Committee. Josie Bacallao reviewed the legislative priorities all of which are tied to HUF's mission. This year, we also will be representing the Children of Immigrant Families Coalition and discuss the top six legislative items from that group with legislators and their staffs during Broward Days in Tallahassee on Jan 21 & 22.

Rolando Garcia provided a motion to approve HUF 2020 Public Policy Platform. Steve Sampier provided the second and the motion passed.

Consent Agenda

Scott Karlen motioned to approve the consent agenda and Anthony Abbate provided the second. The motion passed.

Executive Session

The board members met with Josie Bacallao and Virginia Cielo. A separate package had been sent to the board which included a memo recapping Felipe's salary history and the CEO's recommendations, a market salary analysis prepared by Virginia Cielo and Felipe's most recent performance review. The board approved both a performance and adjustment salary change.

Motion: Willy Gomez moved to discussed salary change and Steve Sampier provided the second. The motion passed.

Governance Committee Meeting Minutes December 6, 2019

Next Steps/Action Items:

- 1. Shani Wilson will share a draft letter (board member gift) for January 2020 for the committee and Lucia Rodriguez to review. Josie Bacallao also discussed creating a policy regarding the annual gift and scorecard.
- 2. Angie Stone and Steve Sampier will provide draft job descriptions and annual calendar for the Executive Committee positions in January.

Discussions:

- 1) Approval of November minutes to be approved at the January 2020 meeting along with December 2019 minutes.
- 2) Individual Contributions: Timing of term v.s contribution amount billed. HUF staff outlined the current process: Board Member gifts are linked to when the board member joins the board. If he/she joins January June, he/she will be invited to make a full year gift to HUF. If he/she joins in July through December the contribution is prorated per month. The committee decided to postpone the discussion on the \$2,500 give/get fundraising by each board member.

As of 2020: A letter from the board chair will be sent inviting that a gift be made (vs an invoice).

It was further discussed to soften the invoice letter from the Chair at the beginning of the year, requesting the annual gift. For those that come in the middle of the year, it was recommended that the word "gift" is used in the letter and emphasize the importance of the \$1k gift to HUF's mission. Set the expectations of the onboarding and recruitment.

Shani Wilson will share a draft letter for January 2020 for the committee and Lucia Rodriguez to review. Josie Bacallao also suggested that staff and committee create a policy regarding the gift and scorecard to memoralize the agreed process.

- 3) Succession planning: Consider recommendation for Committee Vice Chairs
 Recommend to the board that certain committees use Vice Chairs, particularly the Finance committee. It is the role of the Chair of the Board to appoint Vice Chairs. The Governance committee can also aid in providing recommendations.
- 4) On Boarding: Executive Committee in January (job descriptions and annual calendar) Steve Sampier would like to review and edit the officer job description. Angie Stone agreed to assist Steve Sampier in the job descriptions.
- 5) Planning for 2020 Governance priorities

 Steve reviewed the work plan and will suggest including the annual CEO performance review along with salary comparison. Steve said it is the Executive Committee's responsibility to remind the Finance committee and the Secretary will monitor the board calendar, to make sure the calendar deadlines are met. Also review the entire

- 2) Board Member Emeritus description was shared by Steve Sampier. He underscored that historically the designation is given to someone who has gone over and above their board member commitments.
 - a) Hector Lima: Committee Members who had served with Hector on the board shared their thoughts on Hector's service and many contributions.

Motion: Tony Abbate made a motion to honor Hector Lima with Board Member Emeritus. Jorge DeApocada provided a second. Angie Stone abstained from the vote (previous Citrix colleague and believed it was a personal conflict for her.) Vote taken and Hector Lima was not recommended to the board for Board Emeritus.

(Melida left the committee meeting prior to a discussion about her Emeritus status.)

Melida Akiti's history with HUF and her many contributions were discussed by the committee members. It was noted how Melida was "always there" and brings amazing support to HUF. And, how she always adds to important conversations by challenging assumptions and providing a different perspective.

Motion: Tony Abbate made a motion to honor Melida Akiti with Board Member Emeritus. Angie Stone provided the second and the motion carried.

3) Vice Chair Consideration Job Descriptions. This committee can share recommendations to the Chair, Lucia Rodriguez. Melida Atiki asked if this Vice Chair position was approved by the board. 1) Updates on funding for Census, Advocacy and Immigration Fellowship.

Josie Bacallao shared that HUF had just been awarded funding from Chan Zuckerberg Foundation for a one year fellowship to work on immigration policy, and specifically to build up and work through the Children of Immigrant Families Coalition. Realistically, that individual will begin in late Spring. We have also been funded by The Kresge Foundation and a portion of the funding will be used for Advocacy. Lastly, we received two small grants from both the Annie E. Casey Foundation and Florida Counts to work specifically on the census. It will allow HUF to hire a Census Campaign Manager.

2) Review HUF and Children of Immigrant Family Coalition Legislative Agendas and Strategies. HUF's policy priorities were posted on the blog and what we will be discussing with electeds in Tallahassee during Broward Days on Jan 21 & 22. Our focus will be Children of Immigrant Families legislative issues. Carolina Cardozo will attend Broward Days with Josie and Felina.

Josie was invited to participate in a small roundtable with policy leaders by the Atlanta Federal Reserve. The focus of this one-day event (and trip) will be economic disparity.
